The article compares the BDS movement with the international campaign against apartheid in South Africa (an inspiration for BDS) and discusses why BDS has been less effective.

They cover the First Intifada and (after the mainly armed resistance of the Second Intifada) the growth of nonviolent forms of protest since the building of the Separation Wall in 2005.
